Mrs. Pilkington suggested raising the teacher classroom supply limit to \$200. Mrs. Bailey suggested giving them a bonus amount for classroom supplies this year. The administration will research this topic and it will be addressed at a future meeting.

Mrs. Ragon suggested that the School District pay for student school supplies. There was discussion regarding the cooperative style of combining student supplies. The administration will research this topic and it will be addressed at a future meeting.

Mr. Johnson updated the Board an offer the district received from Ameren Illinois regarding the additional easement request.

Mr. Johnson updated the Board on the removal of equipment from Homewood Heights playground. The Village Board agreed to remove all of the playground items beginning tomorrow.

Mr. Johnson updated the Board regarding the attempt to realign the residences located in Creve Coeur that are in Pekin 303 District to East Peoria District 309 that would allow all Creve Coeur students to attend the East Peoria High School.

Mr. Johnson notified the Board that the publication notice for the sale of the Tumble Trak will be published on June 23, 2021 and bids will be accepted through noon on July 6, 2021.

A final report has been provided from ROE 53 regarding the compliance visit and a Fully Recognized Status has been issued to the Illinois State Board of Education.

Summer Registration will be held on Wednesday, July 28 and Thursday, July 29 from Noon to 6;00 p.m. each day for the 2021-2022 school year.

Mr. Bevard updated the Board on the first session of the Summer School program.
