

RESOLUTION NO. 15-12

**RESOLUTION MAKING TAX LEVY**

WHEREAS, the Board of Education of Creve Coeur School District No. 76, County of Tazewell, State of Illinois, has caused to be prepared in tentative form a levy designating the amounts of money estimated to be necessary to be raised by taxation for this year upon the taxable property in Creve Coeur School District No. 76, the same being less than one hundred five percent (105%) of the prior year's extension of taxes; and

WHEREAS, the Secretary of this Board of Education has made said tentative levy conveniently available to public inspection for at least twenty (20) days prior to final action thereon; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF CREVE COEUR SCHOOL DISTRICT NO. 76, COUNTY OF TAZEWELL, STATE OF ILLINOIS, as follows:

SECTION 1: That for the next ensuing year, the County Clerk of Tazewell County is hereby authorized and directed to extend the following special taxes in behalf of this School District:

the sum of \$830,693 dollars to be levied as a special tax for educational purposes, and

the sum of \$130,851 dollars to be levied as a special tax for operations, and maintenance purposes, and

the sum of \$77,895 dollars to be levied as a special tax for transportation purposes, and

the sum of \$29,089 dollars to be levied as a special tax for working cash fund purposes, and

the sum of \$93,090 dollars to be levied as a special tax for municipal retirement purposes, and

the sum of \$137,083 dollars to be levied as a special tax for social security purposes, and

the sum of \$0 dollars to be levied as a special tax for rental of facilities owned by the State of Illinois as provided by the Capital Development Board, and

the sum of \$25,973 dollars to be levied as a special tax for fire prevention, safety, energy conservation, handicapped accessibility, and school security purposes, and

the sum of \$154,372 dollars to be levied as a special tax for tort immunity purposes, and

the sum of \$10,394 dollars to be levied as a special tax for special education purposes, and

the sum of \$24,635 dollars to be levied as a special tax for leasing educational facilities or computer technology or both, and temporary relocation expense purposes on the taxable property of our school district for the year 2015.

SECTION 2: That the foregoing amounts of money, as indicated on the Certificate of Tax Levy hereto attached and made a part hereof, shall be raised by special tax for the various purposes as in said Certificate of Tax Levy indicated for the next ensuing year.

SECTION 3: That the President and Secretary are hereby authorized and directed to sign said Certificate of Tax Levy and file or cause to be filed with the County Clerk of Tazewell County on or before the last Tuesday in December of this year.
